Sub Committees and Working Parties

1.1. Presidents Bench

Alan would like the Bench to be sited on the middle Car Park. It was suggested that a suitable area be marked out and plot holders asked their opinions. The top space could then be used as a Car Park. John Bland, Mick Clayton and John McQuay to look at the two areas and make an assessment.
