We have 118 plots: - Court Oak has 78 Plots Tennal Lane has 30 Plots.

CORRLAA was formed on 29 June 2010 when a committee was elected and recognised by Birmingham District Allotment Council (BDAC); we are an affiliated member of the BDAC and receive information and invitations to attend their meetings. CORTLAA was subsequently recognised by Birmingham City Council (BCC) as the legally constituted Association to manage the above two sites on behalf on behalf of BCC.

CORRLAA succeeded Tennal Guild (TG) in this capacity and received funds and stock when it was wound up. We were pleased to elect Alan Harbour Secretary of TG as our Honorary Life President

CORRLAA has a constitution based a model determined by BDCA (see the Website) and is required to manage the two sites in accordance with BCC Allotment Rules. One of our principal responsibilities is to collect the rent and we are paid 8% of rents collected by the Committee. **If you pay your rent directly to BCC, we do not receive commission**. We expect to receive £226 commission in 2012; this is a relatively small sum for the considerable amount of work undertaken by the Association.

BCC Allotments Department has no funds to assist allotment associations. Therefore, CORTLAA must seek to generate its own funds: we have three principal sources of regular income.

1) Rent Commission £226 2012

2) Membership £140 2011/2012

3) Shop

➤ Net Income first year £ -10 (loss) 2010/2011

➤ Net Income second year £ 842 2011/2012 (sales less purchases)

In addition we seek financial grants

The Shop seeks to provide convenience by opening most Sundays 11:00 -12:00 and Saturdays during Spring/Summer and we buy in bulk to sell at competitive prices. We hold approximately £800/£1,000 of stock and volunteers staff the shop. This is a heavy burden and new volunteers to help in the Shop would be welcomed. CORTLAA has a legal requirement and can only sell to members of CORTLAA. It is currently £2.00 pre year for membership and your membership card which must be produced at point of sale. This year membership subs have generated £150. We are seeking to recruit additional Associate Members from the immediate area to increase our customer base and income.
